has a fleet of 42 helicopters.

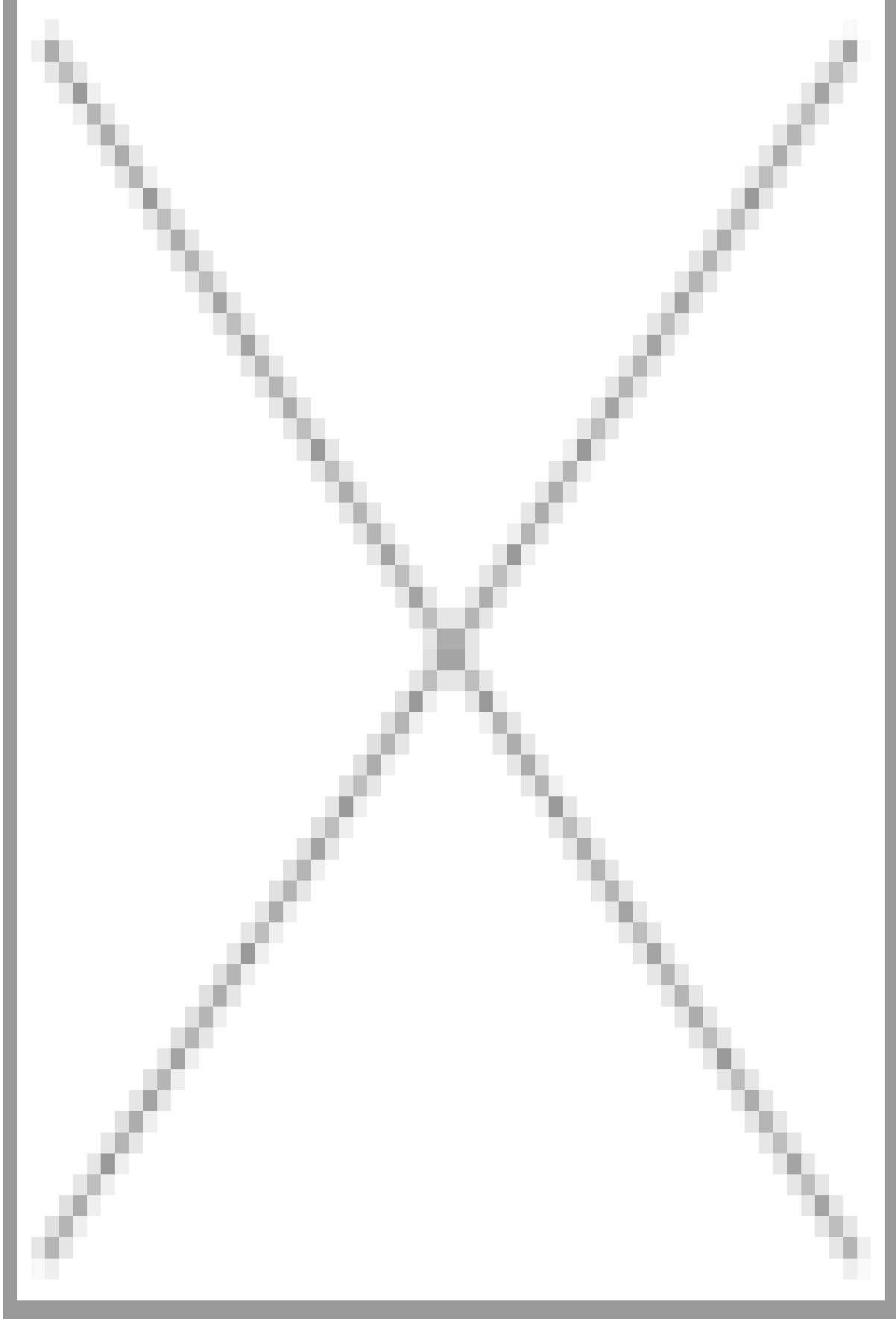
