Jet OUT expands to Arizona with its third regional base opening at Scottsdale Airport. Operations began in early May, with the facility reaching full capabilities by late summer. Jet OUT Scottsdale team will include 14 locally based employees, including pilots, maintenance professionals, customer service, and sales. The 3,000-square-foot facility will feature a private customer lounge, a dedicated sales office, and an on-site line maintenance base to support local operations.

Joseph Crivello, CEO of Jet OUT commented: "Expanding to Scottsdale is a natural next step as we continue to grow. We are excited to bring Jet OUT's unique local-national fleet to a new market, while enhancing access and service for our existing owners and clients. By unifying a national network of regional bases, we can provide our clients the operational benefits of home-basing their aircraft, without sacrificing the program benefits and sophistication that only a national operator can offer. With our tech-forward mindset and commitment to efficiency, we focus not just on how people fly, but on how we can deliver more value," said Crivello. "Jet OUT is designed for customers who expect clarity, control and personal service."

Jet OUT will station two factory-delivered Citation CJ4 Gen2s in Scottsdale, enabling service for up to 16 owners per aircraft. With a home-based fleet and dedicated in-market support, Jet OUT offers a tailored aviation experience combining personalized service, convenience, and value for its community of like-minded co-owners.



The company offers two core programs – Co-Ownership and Co-Lease. Both options provide 20 flying days per share, per year, with terms ranging from one to five years. The Scottsdale launch will also introduce a new product called Co-Lease 10, a 12-month program that offers 10 annual flying days, designed to make private aviation more accessible with a reduced commitment.

Founded in 2018, Jet OUT streamlines private aviation, focusing on “Nonstop Efficiency.” By operating exclusively with factory-new aircraft and stationing its fleet near co-owners, the company passes significant savings directly to customers through transparent pricing. This has fueled the rapid growth of Jet OUT’s programs, establishing it as the fastest growing among the top 25 light jet operators in the U.S.

To ensure customers have a clear understanding of their travel options, Jet OUT provides an online Cost Calculator. This tool allows prospective clients to understand personalized pricing based on their specific needs, offering the opportunity to compare market rates for fixed and variable costs. Recognizing the power of its growing community, Jet OUT offers its Insider Program, rewarding referrals with a complimentary round-trip flight for both the referrer and the new co-owner or co-lessee.

Jet OUT opened its second regional base in September 2024 at Fort Lauderdale-Hollywood International Airport, adding to its first location at Milwaukee’s Mitchell International Airport.
