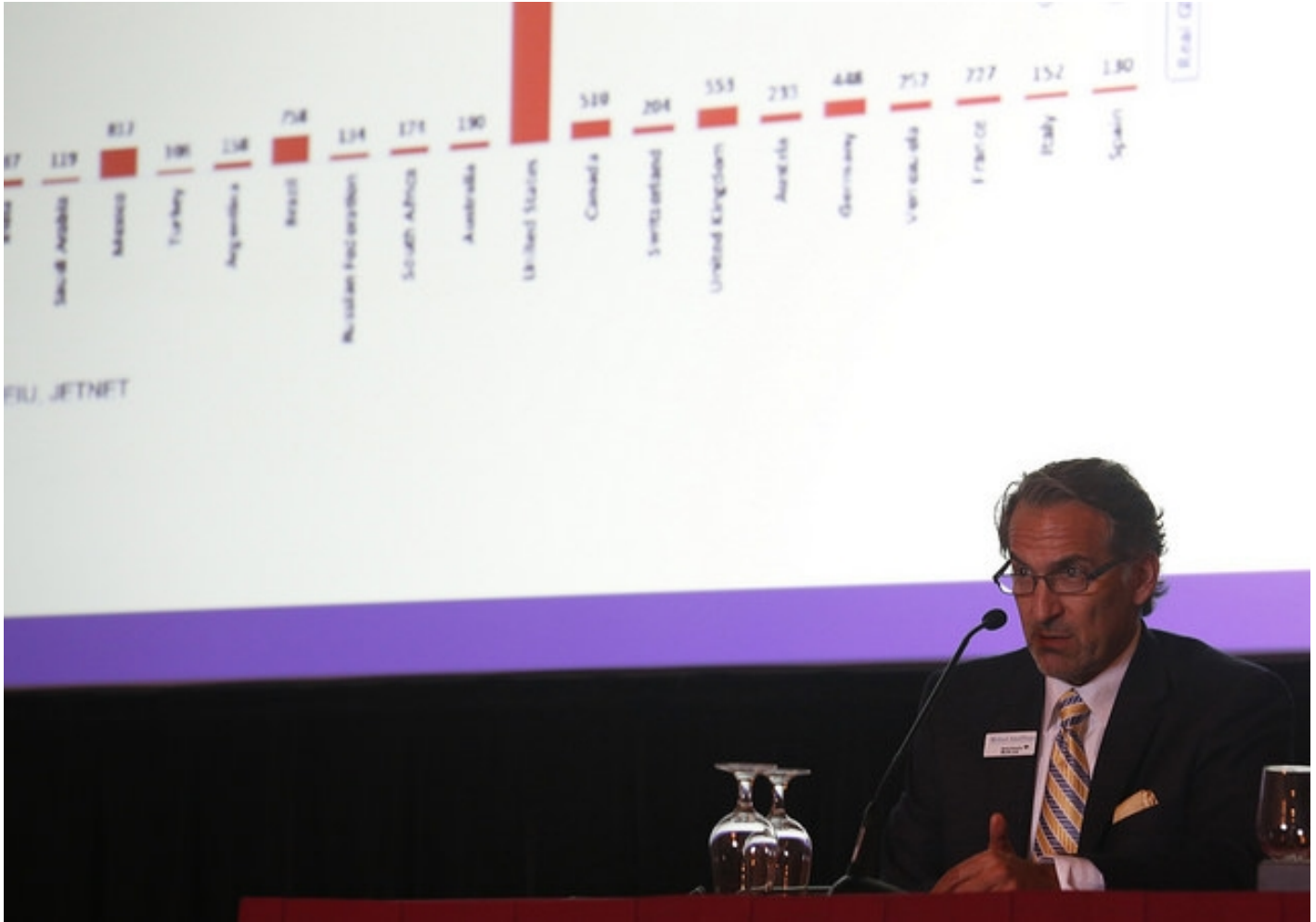




STONEBRIAR DELIVERS \$9.8M DEBT FINANCING
